Policy-Forbidding Student from taking part in Any Political Activity

Purpose:

The purpose of this policy is to establish guidelines regarding student participation in political activities at MCM, Peshawar. The policy aims to maintain a neutral and inclusive educational environment, ensuring that students can focus on their academic pursuits without undue influence or distractions from political affiliations. Policy is approved in 122th academic council meeting held on 22nd March 2025.

1. Scope:

This policy applies to all students enrolled at Gujranwala medical College including undergraduate and postgraduate students.

2. Policy:

a. Prohibition of Political Activities:

Students at Gujranwala medical college are prohibited from engaging in any form of political activity, including but not limited to:-

- Active participation in political campaigns, rallies, or demonstrations.
- Holding political office or leadership roles in political organizations.
- Promoting or advocating for any political party, ideology, or candidate.
- Engaging in any form of political lobbying or advocacy on or off- campus.

b. Neutrality and Inclusivity:

Gujranwala medical College is committed to maintaining a neutral and inclusive educational environment that respects the diverse political beliefs and values of its students. The college encourages students to focus on their academic pursuits and professional development, free from political distractions or biases.

3. Academic Freedom:

While students are prohibited from engaging in political activities, they are encouraged to exercise their rights to freedom of speech and expression within the academic setting, provided that such expressions do not disrupt the learning environment or violate the policies and guidelines of the college.

4. Disciplinary Actions:

Any student found in violation of this policy may be subject to disciplinary actions, which may include but are not limited to:

- Verbal or written warning.
- Temporary suspension from college activities.
- Loss of privileges, scholarships, or other benefits.
- Expulsion from the college, in severe cases of repeated violations.


5. Implementation:

The implementation and enforcement of this policy shall be the responsibility of the college administration, in collaboration with relevant departments and student organizations. The policy will be communicated to all students through official college channels, including the student handbook, website, and orientation programs.

6. **Review and Amendments:**

This policy will be reviewed periodically to ensure its effectiveness and relevance. Amendments may be made as necessary, with the approval of the college academic council.

By adhering to this policy, Gujranwala medical college aims to create a conducive learning environment that fosters academic excellence, professionalism, and respect for diverse perspectives, while safeguarding the college's commitment to neutrality and inclusivity.
